A strong and active membership has always been a major factor in the long-term success of the individual Lodges, our Association, and our Order and never more so than right now. It is imperative we continue to retain the members we have and attract, initiate, and develop a continual stream of new working members. With the current ongoing stresses and other factors brought on by the Pandemic, membership is a significant concern for this 2020/2021 year and will probably be so for the 2021/2022 year as well. For the first eight months of this year (2020/2021), we have seen a net gain of 513 members across the Association, with currently 2311 delinquents and 330 individuals waiting for initiation. It's certainly not a good picture, and while the numbers have improved over the last month or so, we are on track to potentially lose around 1500 members this year. Over the next three months, there is much work to do if we expect to complete 2020/2021 with little or no loss. This issue can only be addressed and solved at the individual Lodge level.

Every Lodge must have a designated team working a non-stop campaign. Convince every delinquent member they are WELCOMED, WANTED, and most importantly NEEDED if their Lodge and its important community work is to continue and perhaps survive. Every Lodge needs the revenue that a member brings to the Lodge in the form of dues and goods and services purchased, as well as the potential manpower. Every member represents the possibility to fill a position of leadership and the workers needed to do the many things required for a Lodge to function properly. There needs to be a continual and ongoing effort to build and maintain a relationship with every member that keeps the member wanting to be a part of the Lodge, what it does, and what it stands for.

Many times, members are delinquent simply because the Lodge fails to bill them. Many of our members today prefer to use a credit card for their bills, and they are used to being routinely billed, which most Lodges don't or can't accommodate. Grand Lodge now offers an optional Billing

Renewal Program where a contracted third party (OSG) routinely mails invoices to members and takes payment via credit card, etc. The cost to the Lodge is \$0.32 per invoice mailed – less than the price of a stamp and no work for our Secretaries. I encourage all Lodges to look at this optional service on the Grand Lodge website - there is a webinar and detailed information about the program. Only what a Lodge does in building a relationship with every member can eliminate delinquency. However, this service is a tool available to the Lodges that, at a minimum, will lower delinquency at little cost and no effort by the Lodge – it is working across the Order, try it!!

While the first eight months of 2020/2021 have had its share of roadblocks and obstacles, I am confident that the hardworking and dedicated Elks of the MD, DE & DC Elks Association can overcome the challenges we still all face, and that once again, we will have an outstanding 2020/2021 year.

December and the holiday season upon us will be like no other we have ever experienced – keep the faith, hold steady on course, lean on one another, and we will get through these difficult times.

Best wishes to every MD, DE & DC Elk and their families. I wish you continued good health, prosperity, and joy – all the joy you can capture with family and friends. Family and friendships will make the difference and carry us through this individually, and as the premier organization, we are. Merry Christmas and Happy New Year; hopefully, 2021 and the 2021/2022 Elk year will see better days for us all.

And finally, THANK YOU for your unwavering and dedicated support and efforts on behalf of your Lodge, our Association, our Order, and all those we serve – you/we are the BPOE, indeed the BEST PEOPLE ON EARTH!!!

As we enter the New Year, 2021, we are a short three months away from the end of our Elk Year. How are we doing with our ENF Contributions? As of December 7th, the MD, DE & DC State Association was in 21st place nationally. Fourteen of our Lodges have met the Grand Exalted Ruler's goal of \$4.80 per member (that means that 23 Lodges have not). Four Lodges have met our State President's goal of \$10.00 per member (that means that 33 Lodges have not). Take a look at the top 5 Lodges in our State as of December 7th, 2020:

The Mission of ENF is to help Lodges build stronger communities. For the 2020-2021 year, 30 of our Lodges received 81 Grants, which totaled \$210,700. There is excellent work being done in our communities, for our veterans, and our youth. The deadline to submit Grant applications passed on December 31st, so please get your Final Reports submitted. ENF recently launched a new CIP Grant History page where Lodges can review their information and Final Reports due dates.

Last year was difficult for all due to the Pandemic, but I hope all Lodges work diligently with their fundraising in this last guarter of our Elk year to move our State Association forward. And remember, the ENF office must receive all monies by March 31st.

"Don't become Lodge Mayhem like Me."

I would like to wish my Elk family of the great

MD, DE, and DC State Association a Happy and Safe Holiday Season.

As I sit here in my home Lodge of Abingdon 2354, I am looking at how we can make our Lodge more COVID-19 safe. We have sanitizer everywhere, and all touchable surfaces are frequently wiped down. Staff wears masks and gloves, and members/guests social distance while wearing their masks. The threat is not from inside our Lodges; it's coming from the outside.

While we must stay vigilant and on top of the COVID-19 situation, we must look at why it's infiltrating our Lodges. With the weather turning cold, forcing us indoors, and the holidays upon us, it is harder to social distance. We must remain vigilant, continue to use our hand sanitizer, wear our masks, and practice our social distancing. If you do not feel 100%, please stay at home until you feel better. It's also a good practice to take temperatures at the door on everyone who enters the Lodge, not just staff.

Please avoid any unnecessary travel. If you absolutely must travel, please remember to get your COVID-19 test within three days of returning home and quarantine 7-10 days after that. However, there is light at the end of this dark tunnel. The COVID-19 vaccines have been approved by the FDA and CDC and will be distributed to the public in the next few months. Our front-line heroes and elderly are slated to get this vaccine first, and we will see it shortly thereafter.

I urge you to pursue the vaccine when it becomes available so we can get back to some sense of normalcy. Remember to protect our members and their families in this time of darkness, and fondly reflect on those we have lost from this pandemic. As the sun rises on the Bush River, I will leave you with your winter tips from Grand Lodge.

## **ICE AND SNOW** REMOVAL

Ice and snow removal Plan for keepina walkways, steps and parking lots safe for the coming months:



- Determine whether a contractor or Lodge employees or volunteers remove the snow
- Obtain a written contract if a contractor plows and shovels
- The contractor should provide an insurance certificate confirming insurance coverage
- Request that the Lodge be named as an additional insured on the insurance certificate
- Lodges that use employees/ volunteers to remove snow will need salt and shovels

- Salt applied at the right time and location helps with footing
- Clean and dry mats inside the Lodge reduce tracked in snow and water
- Update Members and quests when the weather changes during Lodge events

## SERVICE OF **ALCOHOL TO MEMBERS AND GUESTS**



The service of alcohol is a privilege the Lodge extends to Members and their guests, not a means of revenue for the Lodge. Cutting off a Member or guest who is approaching intoxication is better than defending a multi-million dollar lawsuit.

- Know all State and Local Liquor laws
- Never serve anyone approaching intoxication
- Do not let others buy drinks for anyone who might be close to intoxication
- Stop service to anyone else if they will give drinks to someone approaching intoxication
- No beer kegs, no pitchers and no coolers
- Remind Members/guests not to drink and drive
- Be observant while serving alcohol

- Encourage designated drivers
- Never permit BYOB
- Do not allow games/contests involving alcohol consumption
- An outdoor tent/bar must have a server
- Do not hold a "Happy Hour"
- Never discount prices to promote liquor sales
- "Last call" should be well before closina
- Insist on a taxi or a ride for someone who has too much to drink; and members who have a problem need our help, now!

## **BEWARE OF** SCAMS

Scam artists always follow the money, so look out for the

following: Deposit cash in the bank promptly, do not wait until the next day

- Government agencies & Law Enforcement never ask anyone for cash for any reason
- Do not provide anyone with bank account information
- The IRS never directs Not For Profit Corporations to make special payments
- Someone "in need" requests plane fare and cash since they heard that the Elks do good deeds

On behalf of the ENVSC, I would like to wish everyone a Happy New Year. As we begin 2021, we are still experiencing the effects of the pandemic. Our VA Community Living Centers and State Homes continue on lockdown and are restricting volunteers, family, and friends from visiting our veterans living in these facilities. The Hospital staff says they miss the extra help and support our VAVS Reps and volunteers provide. They also report that our veterans are dealing with isolation and miss the social interaction that our volunteers provide. There has been a decline in the donations of hygiene items, underwear, socks, sweat pants, and other clothing items that the veterans need. Throughout the pandemic, the ENVSC has continued to fund our VAVS Reps with their monthly allotments, so our VAVS Reps have provided cash donations to the VA Holiday Fund, purchased Walmart Gift Cards, electric razors, Canteen Coupons, and clothing items for our veterans at these facilities.

I want to congratulate both Washington-Rockville Lodge #15 and St. Mary's County Lodge #2092 for the recognition they received in the ENVSC Newsletter and at Elks.org. In the spring of 2020, Washington-Rockville partnered with the non-profit Fields 4 Valor Farms to get food boxes into the hands of veterans and families served by the Montgomery County Coalition for the Homeless. With the funds from the Spotlight Grant, Washington-Rockville was able to pay the expenses of packaging and transporting the food baskets. Special thanks to Washington DC VAVS Rep Judith P. Black and all the volunteers from Washington-Rockville Lodge #15. St. Mary's County Lodge #2092 received a Focus Grant for \$10,000.00 and used the funds to supply mattresses, bedding, food, and household goods for veterans exiting homelessness. Many thanks to Trent Manson, Veterans Chairman, and all those who helped and participated with this project at St. Mary's County Lodge #2092.


The Army of Hope continues to receive requests to assist veterans with rent and utilities. The requests we receive are mostly from the VA Social Workers. On November 5th, Cape Henlopen Lodge #2540 hosted a meeting and invited veterans and Representatives from the Wilmington VA. The Representatives answered questions concerning veteran healthcare benefits, compensation, and services. At the meeting, I was able to offer the Army of Hope as an additional resource to assist veterans in need. As a result of that meeting, the Army of Hope was contacted by the Delaware Veteran Services requesting assistance in replacing a lowincome veteran's home heating unit. The Army of Hope Committee approved an expenditure of \$1,600.00 towards the home heating unit. We partnered with other veterans organizations such as Del Vets, Delaware Veterans Trust Fund, and the Disabled American Veterans Organization, As it turned out, our donation was not needed because one of

the organizations anonymously came forward and covered the heating unit's entire cost.

On December 3rd at Newark Elks Lodge #2281, the Wilmington VA hosted a drive-thru Volunteer Appreciation and Awards Luncheon. On behalf of our Association, I attended to accept the Spirit of Service Award, recognizing the MD, DE & DC Elks Association and the Army of Hope for their support and assistance to our veterans. The award was presented to the Association by VA Director Vince Kane, and Chief of Voluntary Services, James Coty. Both Mr. Kane and Mr. Coty thanked the Elks for this year's donations, which totaled over \$31,000.00.

As you know, the Army of Hope is funded strictly through donations and fundraisers. I want to thank Kent Island Lodge #2576 for their donation of \$1,500.00, Newark Lodge #2281 for their donation of \$1,000.00, and PER Carroll F. Hamilton for his donation of \$1,000.00. In these challenging times, Lodges are struggling, but please keep The Army of Hope in mind when preparing your upcoming budgets.

Just because the rest of the world is in shutdown mode doesn't mean our work with drug prevention stops. This pandemic and the emotional damage COVID-19 related shutdowns have caused has pushed the drug overdose and deaths caused by overdose higher and higher. Sadly, the struggle is real and won't be cured by hiding ourselves away until the pandemic is over. Elks National Drug Awareness Program has developed a great tool to aid teachers, students, and parents in our fight to prevent drug abuse. Some local Lodges are already distributing and using the program.

THE ELKS TEEN ZONE WEBSITE is new and improved. The website contains current, accurate, age-appropriate drug abuse prevention information, as well as important "Life Skills" that young people need in order to be successful in today's challenging world. Included on the website are online lessons that can be used independently or incorporated in Distance Virtual Learning lessons. These DVL lessons can be created by teachers, youth leaders, and/or parents. The materials in these online lessons are designed to provide teens with facts and engage them in critical thinking about how drugs affect their lives, behaviors, and different parts of the body. Currently, there are six (6) lessons that have been developed. Topics covered include General Drug Information, Decision Making, Alcohol, Marijuana,
